## मूल कर्तव्य

51 क. मूल कर्तव्य - भारत के प्रत्येक नागरिक का यह कर्तव्य होगा कि वह -

- (क) संविधान का पालन करे और उसके आदर्शों, संस्थाओं, राष्ट्रध्वज और राष्ट्रगान का आदर करे;
- (ख) स्वतंत्रता के लिए हमारे राष्ट्रीय आंदोलन को प्रेरित करने वाले उच्च आदर्शों को हृदय में संजोए रखे और उनका पालन करे;
- (ग) भारत की प्रभुता, एकता और अखंडता की रक्षा करे और उसे अक्षुण्ण रखे;
- (घ) देश की रक्षा करे और आह्वान किए जाने पर राष्ट्र की सेवा करे;

# THE CONSTITUTION OF INDIA

## PREAMBLE

**WE, THE PEOPLE OF INDIA**, having solemnly resolved to constitute India into a <sup>1</sup>**SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC** and to secure to all its citizens :

**JUSTICE**, social, economic and political;

**LIBERTY** of thought, expression, belief, faith and worship;

**EQUALITY** of status and of opportunity; and to promote among them all

**FRATERNITY** assuring the dignity of the individual and the<sup>2</sup> unity and integrity of the Nation;

**IN OUR CONSTITUENT ASSEMBLY** this twenty-sixth day of November, 1949, do **HEREBY ADOPT, ENACT AND GIVE TO OURSELVES THIS CONSTITUTION.**

# THE CONSTITUTION OF INDIA

## Chapter IV A

### FUNDAMENTAL DUTIES

#### ARTICLE 51A

**Fundamental Duties** - It shall be the duty of every citizen of India-

- (a) to abide by the Constitution and respect its ideals and institutions, the National Flag and the National Anthem;
- (b) to cherish and follow the noble ideals which inspired our national struggle for freedom;
- (c) to uphold and protect the sovereignty, unity and integrity of India;
- (d) to defend the country and render national service when called upon to do so;
- (e) to promote harmony and the spirit of common brotherhood amongst all the people of India transcending religious, linguistic and regional or sectional diversities; to renounce practices derogatory to the dignity of women;
- (f) to value and preserve the rich heritage of our composite culture;
- (g) to protect and improve the natural environment including forests, lakes, rivers, wild life and to have compassion for living creatures;
- (h) to develop the scientific temper, humanism and the spirit of inquiry and reform;
- (i) to safeguard public property and to abjure violence;
- (j) to strive towards excellence in all spheres of individual and collective activity so that the nation constantly rises to higher levels of endeavour and achievement;
- <sup>1</sup>(k) to provide opportunities for education to his/her child or, as the case may be, ward between age of 6 and 14 years.

## Preface

**T**he Student Handbook on Security for level 4 (Class XII) is a part of the Qualification Package developed by the Security Sector Skill Development (SSSDC) under National Skill Qualification Framework (NSQF) for unarmed security guard (private security sector). The Private Security Sector in India is emerging as an important provider of security services to the individuals and businesses. Security situation becomes serious, if terrorism gets added to the existing list of risks and threats. Private security, due to its large presence on the ground can really help in making a society safe.

The PSS offers lucrative career options to everyone. There are executive, supervisory and managerial posts within the sector, which a person, depending on his or her ability and qualification can aspire to achieve. Private security is no longer a manpower intensive sector. Modern technology such as computers, biometrics, scanners, detectors, sensors, alarms, surveillance devices and communication systems are being used extensively in the PSS.

This Student Handbook on Security for level 4 (Class XII) has been prepared to introduce students to some of the central issues and concepts in the study of security in general and private security in particular. It touches upon the concept of Security of Premises and Property, Introduction to Technological Aids in Security Operations, Legal and Procedural Requirements in Security Sector (Advanced), Basic Security Operations, Security through Surveillance and Protection Systems, Responding to Security Incidents and Breaches and Work Integrated Learning etc.

To achieve these objectives, Central Board of Secondary Education has started a vocational course in Security. After necessary knowledge in security, the students will have an edge over others in getting jobs in this sector.

This book is authored by professionals in the field of security under supervision of PSSCIVE with a focus on real world of security in an interesting and lucid manner.
