structure and beliefs of social environment.


for ex- India through principle of Non Alignment Movement.

Hence man can change the environment as well as gets changed by it.



1. (b) Though it may seem that accountability and efficiency are antithetical to each other, accountability is a sine qua non for good governance. Discuss. (150 words) 10



Accountability is being answerable for the tasks being assigned and take responsibility of the outcome. while efficiency is using optimum resources and achieving maximum outcome which is good.

It looks like both are antithetical. Since accountability leads to unnecessary delays, public servants might not take efficient decisions because of unnecessary scrutiny, it seems like efficiency reduced by accountability.

However accountability is needed for good governance as:

- ① It leads to better usage of resources
- ② Reduce corruption
- ③ Maintains objectivity and stick to rules and regulations
- ④ Efficient decision making.
- ⑤ Ethical behavior of public servants.



Hence it is necessary for maintaining efficiency along with enforcing accountability.

2. (a) Gandhian ideals can be of immense help in dealing with the Covid-19 pandemic. Evaluate.



Gandhian ideals can be of great help in dealing with situations like - COVID-19 pandemic.

- ① Concept of Sanvodya suggest that every individual and every country should get benefit from vaccine development.
- ② The haphazard and rampant destruction of environment has led to spilling over of virus from animals to humans. It can be checked by following- "Earth is enough for everyman's need but not for greed".
- ③ Ideal of truth on the part of China (origin of virus) can lead to proper understanding of origin of virus and quick

development of cure and vaccine.

- ④ The ideal of Cooperation can lead to countries coming together for discovering the cure. (for example - solidarity trial by WHO).



However companies (MNCs) like - Pfizer are resorting to profit seeking and making vaccine like a monopoly and not giving to last man.

Hence ideals of Gandhiji can serve to address the pandemic of COVID-19.

2. (b) While civil servants have the legal right to undertake post-retirement jobs, it raises key ethical issues. Comment. (150 words) 10


Post retirement jobs by civil servants, be it in public sector or private sector raise a question on authenticity and intentions of decisions taken during service under government.

Ethical issues involved

- ① Political influence on civil servants might increase. It may lead to politicisation of governance.
- ② self interest (i.e. benefit after retirement) can undermine spirit of public service.
- ③ It affects the work culture of the department.
- ④ It is against the deontology approach where means are important than ends.

- ⑤ It might affect the trust of public in bureaucracy.
- ⑥ The integrity, honesty, dedication of public servant comes under question.

for example - A judge who gave a decision in favour of ruling party should not accept any public office or seat of MP/MLA.



However civil servants have right to take job in post retirement. But they should refrain from any job that has any connection to erstwhile public life of civil servant.

The quote is true in its entirety. Man is a social animal and he needs support of society for survival. This support is possible only when he follows ethics.


Durkheim even went on to say that economic success in an abrupt way and without integration with society can lead to suicide.

Today people, countries, organis-

ations are running behind materialism, which have lowered ethics in society.

In present context it means:

- ① Race to success and greed has lead to environmental degradation because of lack of environmental values.
- ② International relations today are driven by narrow vision of success. for e.g. USA attacked Afghanistan etc.
- ③ Short term 'success' race has led to corruption, nepotism etc. in public service.



Hence success should always be achieved with sticking to ethical values.

3. (b) Having knowledge of an unethical act and allowing it to continue can spread a contagion that can affect multiple beings in society. Bertrand Russell

Knowledge of an unethical act and not taking action to address it shows lack of value of courage and fortitude.


Unethical act is like a weed which spreads from one being to other.

Not supporting an unethical act while knowing it is similar to taking part in that act:

In present context it means

- ① while knowing about a crime and reporting it to police can ruin the whole society. for e.g. drug cartels.
- ② Not reporting corruption to authorities of department encourage it to flourish.

- ③ People many time ignore the environmental degradation being done by people and companies.
- ④ Criminalisation of politics (an unethical act) is flourishing because people are not voting out the criminal candidate.
- ⑤ People need to stand for the ethical values of the society and check this Contagion.



Hence doing and taking action about Unethical act can only check such acts and uphold ethics in society. It requires fortitude on part of citizens.

4. (a) When people use a common resource without a coordinated plan the result is often a tragedy of the commons in which the resource is depleted. In this context, discuss the various ethical challenges arising out of utilization of Global Commons. **(150 words) 10**


Global Commons include
global climate, oceans, lakes,
forests, Arctica, Antarctica etc.

In recent decades, countries driven by narrow self interests have exploited nature in an unsustainable way.

Ethical challenges

- ① Exploitation of global Commons by one country affects others also. It raises question about justice.
- ② Countries are not taking responsibilities for their negative impact on environment (i.e. common but differentiated responsibilities)

- ③ Big capitalist countries are emitting green House gases, and small, lowlying countries like- maldives are bearing the brunt.
- ④ Marine pollution is affecting all countries
- ⑤ Global warming is affecting all countries irrespective of emission by them.
- ⑥ Ethical dilemma of development vs. environment conservation



Hence Gandhi ji's maxim of stewardship and trusteeship are required along with cooperation of all countries to harness global commons.

4. (b) While a code of conduct merely establishes minimal standards of conduct, a better strategy to promote ethical work culture is through internalization of values. Discuss. (150 words) 10


Code of Conduct defines the expected behavior and actions from members of an organisations.

A Code of Conduct establishes minimal standards of conduct. for eg. The public servant must not take bribe, he must ~~not~~ avoid being insolvent etc. are examples of Code of Conduct.

However internalisation of values is more sustainable and provides long term ethical behaviour to people. It is better as:

- ① It helps in solving conflict of interests.
- ② solves ethical dilemmas.

- (3) Ethical decision making
- (4) values like - empathy, compassion, public service spirit can be internalised for public welfare



Having a Code of Conduct can merely prescribe what sort of actions are allowed but a code of ethics and internalisation of values makes the decision making ethical and well being of society, organisation and various stakeholders.

5. (a) A state that does not have the political will and the discipline to enforce probity in governance, can not get rid of the menace of prolonged corruption. Discuss. **(150 words) 10**



Reasons of Corruption in India

- ① Undue political influence on bureaucracy and politicisation of bureaucracy.
- ② Political leaders and bureaucrats nexus. ex- 2G Scam, Coal Scam etc.
- ③ Lack of Code of Ethics to enforce probity in governance.
- ④ Outdated Code of Conduct and rules.
- ⑤ Improper functioning of RTI, CVC & CBI etc.

⑥ poor work culture of government department to enforce probity.



Here there is a need of political will to reform the civil services and at the same time ethical values of integrity, dedication etc. need to be inculcated in civil servants to check corruption.

5. (b) India cannot march successfully in to the 21st century with the administrative system having a colonial mindset. Discuss in context of the bureaucratic work culture in India. **(150 words) 10**



- democratic attitude along with following rules and procedures

Hence India needs to take democratic attitude for successfully develop all sections of society.


Governance is using power in legitimate way and use resources of a country for its welfare. whereas good governance is where people are stakeholders and government work welfare of people and is accountable and transparent.

Participation of people in governance leads to:

- improved accountability and transparency.
- understanding local situations and using resources appropriately.
- people can put check on misuse of power through instruments like - social audit.

Easy access to information leads to:

- transparency and accountability.
- public officials take rational and objective decisions because their decisions can be scrutinised later.
- Empower Citizens
- reduces Corruption and nepotism



2nd ARC has called Right to Information (RTI) as beacon

light of transparency. Hence both information and public participation are prerequisite of good governance.

8. It is sometimes believed that moral scrupulousness in one's private life automatically guarantees high moral stature in professional life. Do you agree? Justify your stand with logical arguments. (150 words) 10

Ethical behavior of a public servant is grounded in ethical behavior of his in personal life. The values a person shows in his private life are clearly expressed in his public life also.


for e.g. a person who treats his wife with dignity and equality also treats other women with equality in public life.

There is generally a value congruence between behavior of a person in public life and in private life. If it is not so, it may lead to crisis of Consience.

for e.g. a person who is honest, and truthful in his home tries to refrain from corruption and nepotism at public office also.

However sometimes this congruence might not be present. A person can change his behavior in public because of expectations of society. The situations at workplace can also influence the attitude of person.



Hence there is a two way relationship between the moral scrupulousness of a person at public life and personal life.

9. You are working as a District Magistrate in an aspirational district where women literacy and sex ratio is one of the lowest in the country. It is brought to your notice that a woman who has been elected as 'Sarpanch' on a seat reserved for women candidates in a panchayat in your district is head 'only on the paper'. All the work related to the panchayat is actually carried out by her husband. Even the flag hoisting ceremony on Independence Day is carried out by her husband. However, her husband happens to be a good administrator as indicated by that panchayat's performance on various developmental parameters as compared to other panchayats in the district. Also, her husband enjoys the support of the local people. Given the situation, answer the following:

- (a) Identify the stakeholders and issues involved in this case?
(b) What options are available to you as the District Magistrate in such a scenario? Also, evaluate each option and indicate what option will you choose.

Issues involved in the case

- ① low sex ratio and literacy of women shows their neglection by the family. and society at large
- ② Benefit of reservation is not reaching women
- ③ "Sarpanch Pati" phenomenon is perpetuating the inequality and discrimination against women.

- (4) since the area is underdeveloped (aspirational district), women's participation in economy is needed.
- (5) law not being implemented in spirit but only on paper.
- (6) since women are illiterate, they may not be governing the Panchayat well, that's her husband is working as a proxy.
- (7) attitude of society is not egalitarian.

(b) options available to me as a district magistrate

- ① Neglect the issue.
- ② Take tough action
- ③ Use emotional intelligence and change attitude of society.

Evaluation of options

- ① Neglecting of issue might be in good for society in short


term as her husband is efficient and enjoys local support. But in the long term it will perpetuate the inequality. This would be like me being running away from my suspmisibilities.

② Taking tough action and punishing the guilty will serve the short term purpose. Since women are illiterate and unaware, it won't be sustainable as attitude of society will also remain same. But this would be in line with my duty and obligations (deontological approach of Kant)

③ changing the attitude of society will make Empowerment of women sustainable. This attitude change will also lead

to improved sex ratio, literacy of women and economic development of region. This would show my emotional intelligence and pursuing abilities (Holistic Competence)

Preferred course of Action



Here pursuing society, changing it's attitude, taking and implementing programs for women upliftment (i.e. Aspirational district Program of NITI Aayog) will be a sustainable solution. This solution cater to needs of all stakeholders, hence it's a holistic one.

- 10.** The issues confronting humanity are multifaceted - from political conflicts and human rights abuses to pandemics and climate change. They are not contained within national borders, nor do they fit into the silos of separate government agencies or academic specialties. What is required is greater international cooperation, mutual respect, abiding by international laws and participative global decision-making. However, over the last decade, it has been observed that international relations have overshadowed these basic tenets of global governance and now we are at the verge of serious global catastrophic risks. When it comes to the structures of global governance, business as usual, is no longer an option. Not only an improvement in our understanding of risks is required but also taking responsibility to lead collective action for a coordinated global response.

- (b) Provide a case for the moral obligation of the international community to come together and find solutions to the problems we face.
- (c) What should be the principles guiding such international cooperation?

① Factors hindering collective Actions

- ① Narrow self interest of Countries
- ② free riding problem where one country does not want to take responsibility.
- ③ Ineffectiveness of global organisations like UN, WTO etc.
- ④ Conflict between countries.
- ⑤ Lack of research on issues like climate change and lack of consensus.
- ⑥ Lack of global governance.
- ⑦ Lack of ethical values like trusteeship and stewardship.



11. You are posted as Superintendent of Police in a district. A case has come up in which more than 30 girls were allegedly raped and sexually exploited at the city shelter home run by an NGO. The scandal came to light when media flagged complaints of sexual abuse of inmates of the city shelter home. A nexus of police, politicians, administration and criminals have been allegedly responsible for the racket going on for the last few years. In light of this, a lot of protests have erupted across the city.

While, on one hand, media glare has meant that people are demanding swift action, you have been asked to go slow in investigating the case by top officers in your department. Elections in the state are due in a few months, so it has become a politically sensitive issue. You are also under immense political pressure from the ruling party to not take strict action and make compromises to cover up the case.

Given the situation, answer the following:

(a) Identify the issues involved in the case.

(b) What are the options available to you? Which of these options will you choose? Justify your stand with logical arguments. (20)

Hence the above steps will solve problems of all stakeholders and project can be completed properly. Hence it is a holistic solution.

14. Genetic editing has several applications with its potential to edit the genomes of both somatic and germ cells. This allows for the ability to not only cure genetic diseases but to edit the characteristics of future offspring. The last few years have seen the development of several efficient, more precise genetic engineering techniques.

However, with growing sophistication, various issues of bioethics have also have come to the forefront.


a) Ethics and Genome edition

- It may increase gap and inequality between rich and poor. since rich can make use of expensive gene editing but poor will not.
- It will lead to a new generation of "genrich" and "genpoor". Since those with edited genes (ie. designer baby etc.) would have superior qualities while others won't have. Hence inequality in future will perpetuate.
- It is similar to interrupting the natural cycle.
- Research on gene editing in

many countries leads to usage and creation and then disposing artificial embryos

But rights of still unborn embryo are not treated

- we are not considering the rights of a child who is still in womb and scientists are changing his attributes. It's against justice.
- Gene editing may have many unknown impacts on the individual.
- Gene edited Crops are not fully researched. There is no consensus on the benefits and problems of theirs.



b) ethical framework for use of this technology

- There should be first complete research on the potential harms of this technology.
- Ethics Committees in hospitals and research institutions be strengthened.
- Before gene editing, informed consent of individual should be pre Condition.

VISION IAS

- equal access of technology to rich and poor. Subsidy may be provided to poor.
- The technological aspects which hamper the natural cycle of earth should not be used.
- Genes of future offsprings should not be edited. since it may perpetuate inequality.

Hence gene editing technologies are beneficial as well as harmful. At one hand it can cure diseases, on the other hand, it can increase inequality. Thus there is a need of ethical framework to tackle and regulate this technology.
