## **SOLUTIONS**

## 1. Option (2) is correct.

*Explanation:* Under planning incharge four personnel namely instruction card clerk, route clerk, time and cost clerk and a disciplinarian works. These four personnel would draft instructions for the workers, specify the route of production, prepare time and cost sheet and ensure discipline respectively.
