

Option (a) is correct because lady's grandfather's son is lady's father and father's daughter will only be lady's sister.




2. Explanation

Thus, Lily is Raghav's daughter.




Option (d) is correct because according to the question, following relationship chart can be drawn:


4. Explanation


Option (c) is correct. The following relationship chart can be drawn on the basis of given information:




Vidya is wife of Gopi who is brother of Akhil. So Akhil is brother-in-law of Vidya.

Option (d) is correct. 'Only daughter of Rekha's father's is Rekha who is also Sandip's mother. So, Rekha's husband is the father of Sandip.






9. Explanation

Option (e) is correct. From the given statements 'A' and 'C' are the mother and father of 'B' and two more children. None of the given options can be true.


10. Explanation




11. Explanation




